

AGREEMENT OF ENGAGEMENT AND SUPERVISION

REGULATED BY Royal Decree 99/2011 (REGULATED BY THE AGREEMENT 6.1 / CG 23-7-19)

This document constitutes an agreement between the Doctoral Student, the Student's Tutor, the Director of the Student's thesis and EIDUS. To this end, the signatories agree on the terms regulating the thesis' supervision, the resolution of conflicts or aspects of intellectual property that may arise in the development of a doctoral thesis within a PhD program of the University of Seville (Art. 57 of the 6.1/CG 23-7-19 Agreement regulating doctoral studies).

Any modification regarding the direction of the thesis or the tutoring of the Doctoral Student shall result in the revision and re-signing of this written Agreement.

Terms of Agreement of Engagement and Supervision

The signatories of this document commit themselves under the following terms. They hereby declare:

1. **Regulations.** –to know, and abide by the provisions governing doctoral studies according to the valid general Spanish regulations and the specific rules of the University of Seville.
2. **Cooperation.**- to establish collaborative conditions that enable the presentation of a research plan, its subsequent development, and finally the defense of the doctoral thesis in accordance with the procedures and deadlines established in the applicable rules and within the functions that correspond to each signatory.
3. **Obligations.**- to commit themselves in developing the functions assigned according to the valid general national regulations and the specific rules of the University of Seville, as well as to other regulations or developing regulations.
4. **Intellectual and industrial Property.**- to accept intellectual and industrial property rights as well as the system of transferring exploitation rights recognized by the existing legislation at the EU, in Spain and at the University of Seville.
5. **Good Practices.**- to take into account the recommendations contained in the Code of Good Practices for doctoral studies
6. **Procedure for Conflict Resolution.** – to know and apply, as appropriate, the procedure for conflict resolution present in the Code of Good Practices, without prejudicing subsequent resources that are legally due.

7. **Document of Activities of the Doctoring (DAD) Student.**- to complete the necessary information from the DAD, as well as all the actions provided for in the existing regulations within the functions that correspond to each of the parties involved.
8. **Facilitating information.**- to provide any information that may be required for the indicators included in the Quality Assurance System for doctoral programs
9. **Institutional Archives.**- The PhD students commit themselves to provide any data related to their doctoral thesis required by the institutional archives , once their thesis has been defended and evaluated.
10. **Confidentiality.**- To keep confidential all confidential data and information provided or disclosed by the signatories through any means, and to use the information obtained solely on the completion of the doctoral thesis
11. **Confidential Theses.**- to abide by all the legal regulations governing inventions and state aid for research, development and innovation.
12. **Validity.**- This document takes effect from the date of its signing until the issuance of a doctoral degree. In the case of breach of the terms listed above and / or the regulations governing doctoral studies at the University of Seville, this Agreement of Engagement and Supervision shall be terminated. Where any substantial aspects of the document are modified, a new Agreement of engagement must be signed
